 9. The administration reserves the right to delete messages or topics without explanation.
 10. Publishing or selling materials (e.g., mods, phishlets, configurations) provided by the channel is forbidden. Violators will be disconnected.
 11. Adhere to general rules of good manners and accepted norms of behavior.
