### **15. DISPUTE RESOLUTION**

#### **Informal Negotiations**

To expedite resolution and control the cost of any dispute, controversy, or claim related to these Legal Terms (each a "Dispute" and collectively, the "Disputes") brought by either you or us (individually, a "Party" and collectively, the "Parties"), the Parties agree to first attempt to negotiate any Dispute (except those Disputes expressly provided below) informally for at least thirty (30) days before initiating arbitration. Such informal negotiations commence upon written notice from one Party to the other Party.

#### **Binding Arbitration**

If the Parties are unable to resolve any dispute through good-faith discussions, the matter will be settled by binding arbitration instead of going to court. By agreeing to these Terms, you understand that you are waiving the right to sue in court or have a jury trial.

The arbitration will be handled by a neutral arbitrator under the American Arbitration Association (AAA) Commercial Arbitration Rules. The arbitration will take place in the State of Wyoming, USA, and unless we both agree otherwise, there will be one arbitrator.

The arbitration may be done in person, in writing, by phone, or online, as decided by the arbitrator. The arbitrator will apply the laws of the State of Wyoming. The decision will be final and binding, and it can be enforced in any court with proper authority.

Either of us may ask a court to require arbitration, pause a lawsuit until arbitration is finished, or enforce the arbitrator's decision.

Any claim or dispute must be started within one (1) year from the date it arose. If any part of this arbitration clause is found invalid, that part will not apply, but the rest will remain in effect. If arbitration cannot apply for some reason, the dispute must be brought in the courts of the State of Wyoming, USA, and both parties agree to that jurisdiction.

#### **Restrictions**

The Parties agree that any arbitration shall be limited to the Dispute between the Parties individually. To the full extent permitted by law, (a) no arbitration shall be joined with any other proceeding; (b) there is no right or authority for any Dispute to be arbitrated on a class-action basis or to utilize class action procedures; and (c) there is no right or authority for any Dispute to be brought in a purported representative capacity on behalf of the general public or any other persons.

### **Exceptions to Informal Negotiations and Arbitration**
